Requirements for obtaining the 2022 Water Bonus

What are the refundable jobs

- • the supply and installation of taps and appliances for controlling the flow of water with a flow rate equal to or less than 6 litres per minute for bathrooms and kitchens;
- • the supply and installation of shower heads and columns with water flow rates equal to or less than 9 litres per minute;
- • the supply and installation of ceramic sanitary bowls and basins with a maximum discharge volume equal to or less than 6 litres.
